#### OTHER BUSINESS

- A. Staff Reports
  - **A. Deputy Director** Kevin said the proposed asphalt inspection would cost \$1,500 and include the entire trail system with a report.
    - Mr. Haines asked about the proposed recognition area near Farrington Reserve. The conclusion was that the area floods too often to pursue the project.
  - **B. Operations** Dale said the staff spend a lot of time preparing and hosting the Hug the Earth program.

There was discussion on making the LC cabin porch an enclosed area for year-round use and the

costs associated with the proposed project.

- **C. Marketing** Amanda distributed a summary of the Trail Run Challenge and the sponsorships received for it and for the Hug the Earth Festival.
- **D.** Education Susan gave a summary of the week-long Hug the Earth program. During the four-day program, there were 2,705 students, 208 guides/volunteers, 478 adults (chaperones/teachers) with 126 classes that participated. Scott commended Susan and all the staff for the structure and organization of the event. Susan said the watershed program at Kyle schools were great this year.

The Trailing Moms and Tot program has 56 participants yesterday.

E. Executive Director- Scott had no additions to his written report.
