- C. RESOLUTION 1441 -21 Authorization to purchase limestone gravel from C.F. Poeppelman, Inc. to construct an overflow parking area and trails at Stillwater Prairie Reserve at a final cost not to exceed \$14,994.94 Dr. Malarkey made a motion to approve resolution 1441-21, seconded by Mrs. Gutmann, motion carried unanimously.
